



 As we enter our 10th year, I am struck by the profound impact Master Watershed Stewards have made here in Anne Arundel County and across the Bay watershed. Since 2009, over 200 citizens have dedicated themselves to the rigorous Master Watershed Steward certification. Representing 100 communities and 25 houses of worship from Brooklyn Park to Herring Bay, these leaders installed over 2,300 projects and engaged over 134,000 neighbors.

Our original concept of community-based citizen leadership has to include houses of worship, businesses, government agencies and schools. From Steward Jamie Rowell, of Anne Arundel County Parks and Recreation, who singlehandedly eliminated pesticides

and fertilizers on most of our turf sports fields, to Steward Betsy Love whose project cleans and cools stormwater runoff from over 28 densely developed acres in Eastport, the impact of Master Watershed Stewards cannot be overstated.

Most surprising to me is the impact Stewards have beyond Anne Arundel County. Through a partnership with University of Maryland Seagrant Extension, we helped five other WSAs across Maryland grow their own army of citizen leaders. As the co-chair of the Chesapeake Bay Program's Citizen Stewardship Goal Team, WSA is leading an important movement to increase the number and diversity citizen stewards among the 17 million residents of the Bay watershed.

I continue to be proud, humbled and, most of all, certain that our waterways will be restored! I hope you will find inspiration within these pages for your restoration dreams.



# Collective Impact: Caring for Creation Begins at Home for RiverWise Congregations



Sixty-nine members of Asbury Broadneck United Methodist, Fresh Start Church in Glen Burnie and the Islamic Society of Annapolis completed a specially tailored, compressed version of the Master Watershed Stewards Certification Course to learn about the ways they could care for Creation. After getting the waterway restoration bug, **30** of these Congregational Stewards installed projects to reduce polluted runoff from their own properties. In all, **27 conservation landscapes**, **10 tree plantings** and **62 rain barrels** are a tangible reminder to congregants that caring for Creation begins at home.

One congregation, Asbury Broadneck United Methodist Church, has a big problem. Every time it rains, polluted runoff from **34 acres** of uphill development courses through its historic cemetery, pushing up caskets and overturning gravestones. To better understand the hydrology behind the issue, congregants reached out to the Watershed Stewards Academy.

"I reached out to find help and as a resource to educate myself," said church member Kimberly Hickey. Kimberly and three other congregants, Robert Brown, Darius Stanton and Kenyatta Rowell, graduated from WSA's Master Watershed Steward certification course, and 18 members completed the Congregational Steward program. Together with non-profit partners, Watershed Stewards Academy, Interfaith Partners for the Chesapeake and the Alliance for the Chesapeake Bay, stormwater professionals such as Stormwater Maintenance and Consulting, LLC, and funders, MD Department of Natural Resources and the Anne Arundel County Watershed Protection and Restoration Program, the congregation will soon break ground on a project to treat 45,312 gallons of polluted runoff and protect the final resting place of over 2,000 residents, including former slaves and civil war heroes.



"It's been a gift," ABUMC Pastor Stephen Tillett said of the project. "We are grateful."

### Do Something Big: Donate to WSA's Impact Fund

The RiverWise Congregations Program provides technical, faith based assistance to help Houses of Worship care for God's Creation. Through this partnership with the Alliance for the Chesapeake Bay, and the Interfaith Partners for the Chesapeake, Our Creeks and Conservancy, and funded through the Maryland Department of Natural Resources and the National Fish and Wildlife Foundation, WSA engaged 25 congregations, certified 30 Master Watershed Stewards and trained 69 Congregational Stewards. # **Collective Impacts: Community Stewards Lead Neighborhoods to Act**



The Clean Water Communities program connects neighborhoods with the tools to reduce stormwater pollution and improve the health of our waterways. By changing old habits and installing new landscape features, communities reduce pollution and earn a designation as a Clean Water Community.

The first Clean Water Communities, Hillsmere and Linthicum, installed projects such as cisterns, bioswales and rain gardens, reducing their polluted runoff by over 300,000 gallons per year...a BIG IMPACT on local waterways!

This year, two communities embarked on the Clean Water Communities certification. Arnold's Pines on the Severn and Riva's Glen Isle completed a newly created Community Steward program. This compressed version of the Master Watershed Steward certification course gives Community Stewards the tools and inspiration to lead their community to collective action for clean water. Together with their certified Master Watershed Stewards, this team leads behavior change campaigns and traditional stormwater restoration projects. A comprehensive stormwater assessment, completed by the South River Federation and WSA, is helping each community prioritize actions for maximum IMPACT.

In Pines on the Severn, a team of seventeen dedicated stewards, including seniors, young professionals, working parents and a middle school student are adopting best practices for their own properties and encouraging other residents to do the same. Their "Habits that Help" campaign reminds everyone to pick up pet waste and regularly pump septic systems; it also informs residents about the importance of managing leaves and protecting the tree canopy by removing English Ivy. The 10 rainscaping projects on residential property will showcase the benefits of conservation landscapes and rain barrels, and explore native planting methods for controlling runoff from steep slopes.



For a long time, residents in Pines have known about the problems caused by stormwater runoff and erosion, but have been unsure what to do. WSA has empowered our neighborhood by giving us the knowledge, the resources, and the connections to chart the best path forward."




This year, 12 organizations joined together for the **GreenGive and raised over** \$183.000 from 651 donations in just over 24 hours.



## Let's Do Something Big...

Many of the most degraded stream sites and most cost-effective opportunities for large scale restoration are located within communities, but executing this type of project is challenging to say the least. It takes a dedicated community leader and many years of partnership building, grant writing, collaborative design processes and laborious permitting to bring community restoration to fruition. At the center of two recent major projects are Stewards Betsy Love and Molly Lachapelle. Without their tenacious leadership, millions of gallons of polluted runoff from private property and public infrastructure would go untreated.

Using three acres of undeveloped land owned by St. Luke's Episcopal Church and Watergate Pointe in Eastport, Betsy Love is spearheading a system of bioswales, a regenerative stormwater conveyance, and a living shoreline to treat polluted runoff from 28 intensely developed acres. She and her team of fellow Stewards are also creating an educational campus where students of all ages can learn about our amazing natural world and a true restoration of nature.

Over eight years ago, the Berrywood community began to work toward the restoration of Cattail Creek, a stretch deeply degraded by upstream development, but it wasn't until Berrywood got a Master Watershed Steward that their vision became a reality. Steward Molly LaChapelle used skills and connections gained through WSA to win design funding and lead her community through a collaborative design process. This year, a \$900,000 stream restoration and living shoreline project will help to restore habitat for yellow perch and small children alike.

Because of the work of these two amazing Master Watershed Stewards, the health of entire creek systems is being transformed. Thank you Betsy and Molly!



"It's going to take everyone making sure stormwater doesn't leave their property. The problem is so big it's going to take everybody getting involved."—Betsy Love

"When my family moved to Berrywood years ago, my sons fished, explored for frogs, and walked the shallow water for soft crabs. The water used to be clear in the winter as soft bottom sediment would drop out before the tidal area near our house. That no longer occurs due to upstream construction and stormwater runoff. I want my grandchildren to enjoy the water their fathers experienced."—Molly LaChapelle
